Evolution is happening now!

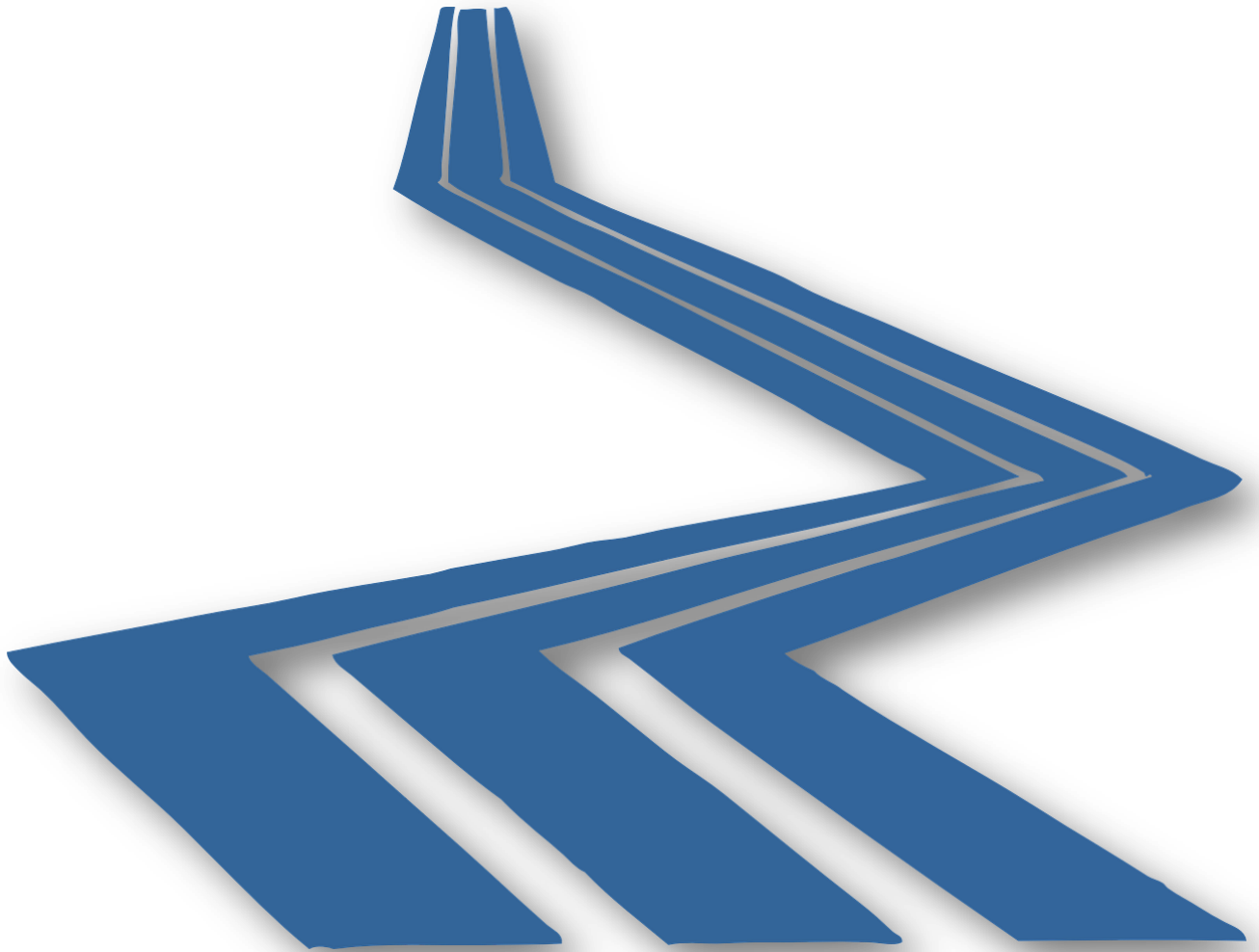

Stage №0

Research work - 2011 - 2013 year.

Formation and testing of the concept of "Man Bank" - 2014.

System architecture and design of second-generation blockchain - 2014 - 2015.

Works on the creation and debugging of the BriaCoin Blockchain Network - 2015 - 2016.

Stage №1

Running a coin into circulation (the initial POW pre-master) BriaCoin - December 2016. Premine was only 1%, this is the minimum required percentage for the successful launch of the PoS algorithm and maintenance of network nodes. In addition, the amount of pre-account includes the provision of a platform for smart contracts, Bounty and ICO campaigns, as well as partial gratuitous distribution of the bank to users.

Development and implementation of its own platform for smart contracts based on the BriaCoin blockchain network - February - December 2017.

Development of a mobile application for a social business network with payment for actions by Briacoins for Android OS - April - May 2017.

Development of mobile BriaCoin purse for Android OS - June 2017.

Implementation of the Scrypt algorithm for conducting transactions in the BriaCoin blockchain network - June - July 2017.

Release of the server version of BriaCoin purse for solo mining on the Scrypt algorithm (outside the pool) - July 2017.

Running the first pool mining on the Scrypt algorithm for instant processing of transactions and bringing the network to real-time mode - July 2017.

Development of mobile BriaCoin purse for iOS (iPhone, iPad) - July - August 2017.

Development of a private chat messenger inside the purse BriaCoin - July - September 2017.

Preparation and implementation of a preliminary investment program for primary investors during which a partial realization of the real shares of the company - developer and premiere of BriaCoin coins on favorable terms - July-October 2017 will occur.

Exit to crypto-exchange exchanges and markets May - December 2017.

Development and publication of the second version of BriaCoin wallets Mac OS / PC Windows / Android / Unix / Linux.

Preparation of the global Bounty campaign - February - July 2017.

Preparation of ICO - May - October 2017.

Primary ICO BriaCoin - October - November 2017 (the exact date is on approval and approval by the development team).

Launch of the advertising CPA / MLM platform - December 2017.

Attraction of Webmasters and publishers on the platform - August - October 2017.

Filling the advertising CPA / MLM platform with contracts - December 2017 - February 2018.

Obtaining primary turnover data and model efficiency.

Stage №2

ICO advertising CPA / MLM network - April 2018.

Promotion of the advertising CPA / MLM network, attracting the maximum possible number of advertisers and webmasters - February - April 2018.

Increase in the turnover of the platform and provision for BriaCoin - 2018.

Development of mobile applications for social network business with payment for actions by Briacoins for MacOS, iOS, Windows 10 - 2018.

Development and implementation of a single cross platform for all operating systems and devices with a single messenger, wallet and all interrelationships of our projects and services 2017 - 2018.

Stage №3

The launch of the SSP / DSP advertising exchange based on the BriaCoin blockchain technology and its own smart contract platform - July 2018.

Run-in technologies and making improvements on the advice of the Top Publishers and Agencies - July - October 2018.

ICO blockchain SSP / DSP stock exchange online advertising - November 2018.

Standardization of contractual relations of the parties and assimilation in the advertising market of the principle of the Smart Contract and the presumption of payment for the result - 2018 - 2019.

Stage №4

The launch of Blockchain Web Business (BBW) with payment for the useful action - September 2017.

Filling and development of the Business Network - September 2017 - March 2019.

Obtaining objective data on the turnover of goods and services, conversion, audience involvement - September 2017 - March 2019.

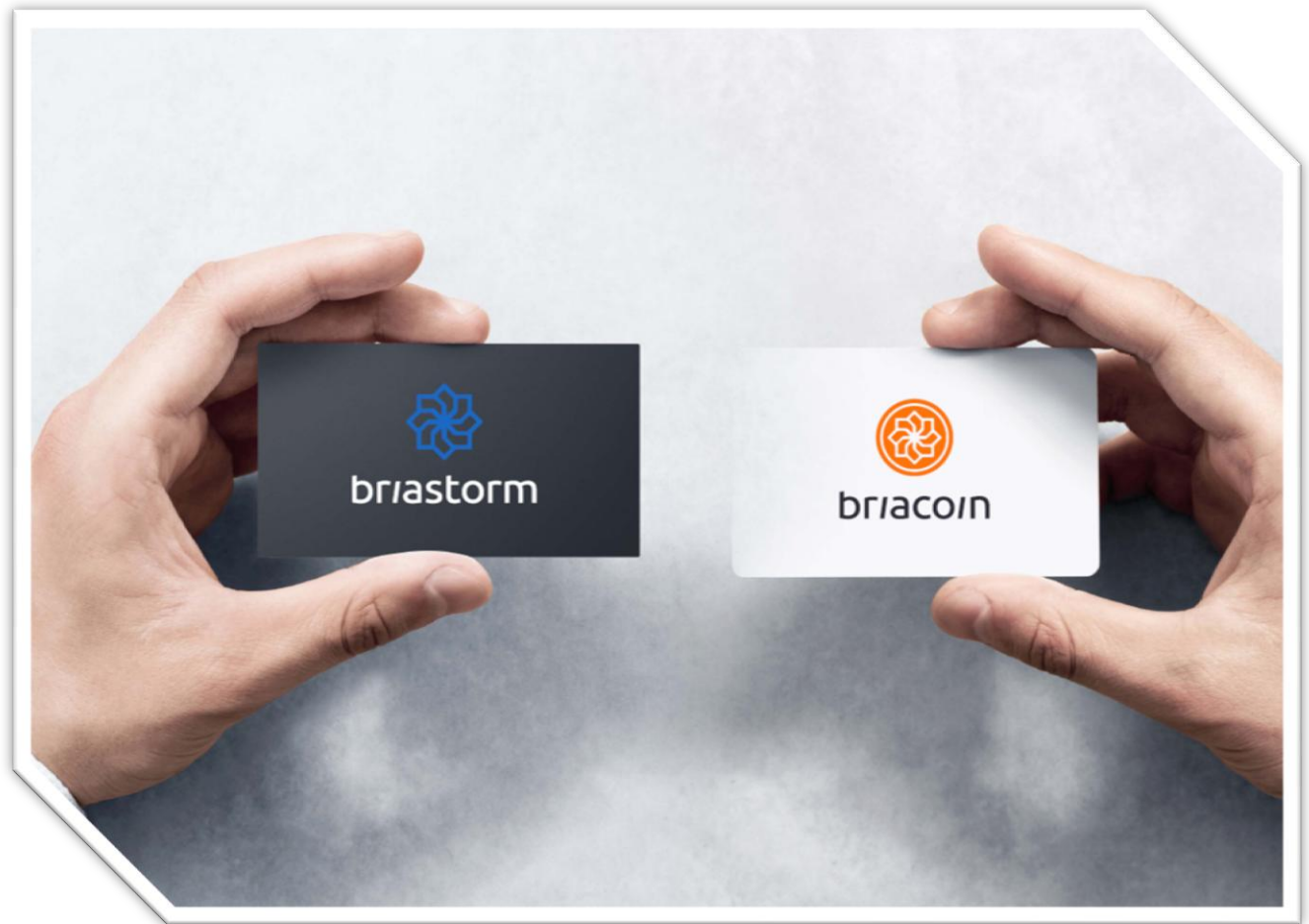
